★EVENTS - PURPLE BELTS & ABOVE ★

SPARRING - As in weekly class, this event is for points only. It is very light contact. Excessive force results in disqualification. Chest protectors and headgear provided. Please bring and label any personal sparring gear. *Mouthpieces are mandatory and boys must wear groin cups.* (There will be a Safety Rules seminar/demonstration prior to sparring competition.)

FORMS - Contenders have 20 - 30 seconds to perform a string of techniques they put together from the techniques taught in class and appropriate for their rank. It is of utmost importance that form consists of techniques taught from AIM USA curriculum only and which is appropriate for students belt level. Judges look for good technique, coordination, balance, focus, speed, power and kiais.

★EVENTS - YELLOW AND ORANGE BELTS ★

SPARRING - As in weekly class, this event is for points only. It is very light contact. Excessive force results in disqualification. Chest protectors and headgear provided. Please bring and label any personal sparring gear. *Mouthpieces are mandatory and boys must wear groin cups.* (There will be a Safety Rules seminar/demonstration prior to sparring competition.)

SHOW WHAT YOU KNOW – While the judge calls out different techniques (Kicks, punches and block combinations, taught in class.) Contenders demonstrate them. Students perform twice. Judges look for effort, good technique, coordination, balance, focus, speed, power and kiai.

★EVENTS - WHITE BELT★

DANGER ALLEY - In this exciting event contenders work their way through four “would be” attackers using their Self-Defense skills (break aways blocks, punches, kicks, and verbal skills). Judges look for effort, good technique, coordination, balance, focus, speed, reaction time, power, kiai and verbal skills.

BEST KICK & PUNCH - In this event contenders twice perform their best *front snap kick and reverse punch*. Judges look for effort, good technique, coordination, balance, focus, speed, power and kiai.

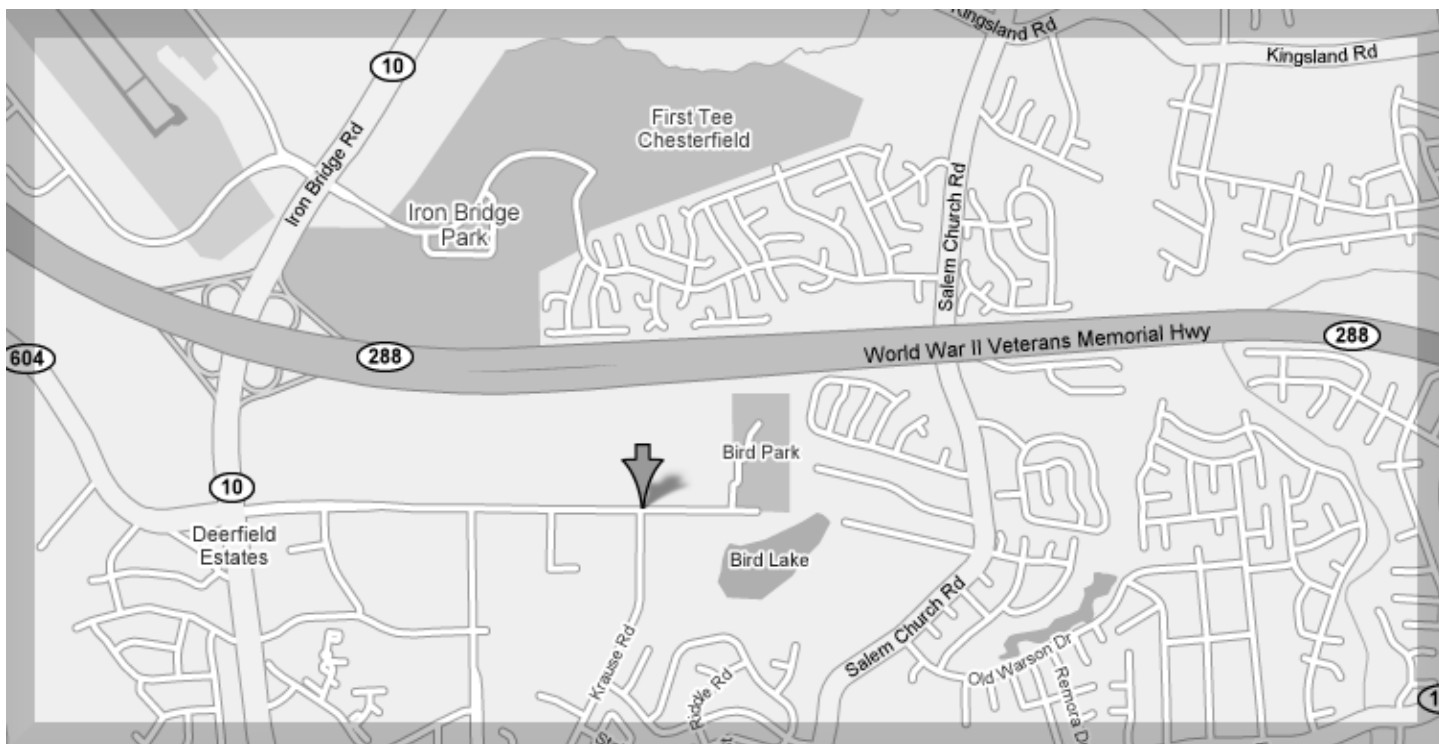
